A complete set of Bidding Documents may be purchased from the office *Aathbiskot Municipality Rukum* (*West*) by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of mentioned below till 30<sup>th</sup> day *during office hours*.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

- 4. Sealed or electronic bids must be submitted to the office *Aathbiskot Municipality* by hand/courier or through PPMO's e-GP system <u>www.bolpatra.gov.np/egp on or before 12:00</u> pm on 31<sup>th</sup> day. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00pm on 30<sup>th</sup> day at the office of *Aathbiskot Municipality*. Bids must be valid for a period of *90 days* after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of following amount, which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 7. Bidders who choose to submit the bid by E-Bidding System, bidders within the specified time shall be considered as non responsive and may cause forfeiture of bid security.
