## Invitation for Bids for Procurement of juice fermentation & Storage Tanks (Second date of publication: 2076/06/17)

- The Aathbiskot Municipality, Aathbiskot Rukum (West) now invites sealed bids from eligible and qualified bidders for the Procurement of juice fermentation & Storage Tanks under international competition bidding.
- Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Public Procurement Act of Nepal and is open to all bidders from Eligible Source Countries as defined in the bidding document.
- 3. Interested eligible bidders may obtain further information and inspect the Bidding Documents from the AMO, Aathbiskot, Rukum (West) on official working days between 10:00 to 17:00 hours (Nepal Time) from 4 October 2019 to 3 November 2019, at their own convenience, on the AMO website www.aathbiskotmun.gov.np and PPMO website (www.bolpatra.gov.np/egp). Interested bidders must first register on the PPMO website to access the document and choose the electronic bidding procedure. A complete set of Bidding Documents in English may be downloaded from the PPMO website upon payment of a non-refundable fee of NRs. 3,000.00 or equivalent convertible currency. The method of payment will be in the form of cash deposit certificate in Revenue Title no. 14229, Office code no. 80659401, Account No. 0920000005GE of Century commercial Bank, Aathbiskot Rukum (West). Foreign Bidders may also pay through a bank draft in favour of the AMO.
- 4. Interested bidders must submit their bid electronically through e-procurement section of PPMO website: <a href="http://www.bolpatra.gov.np/egp">http://www.bolpatra.gov.np/egp</a>. The bidders can download the necessary part of bidding documents, prepare their bids and submit their electronic bids electronically, for this purpose the bidder shall be required to deposit the cost of bidding document as specified above in the above mentioned Account Number of AMO at Century Commercial Bank, Aathbiskot Branch and electronic scanned copy (pdf format) of the Bank deposit voucher/tele transfer receipt shall also be submitted along with the electronic bid files.
- Bidder must submit their bid electronically through e-procurement section in PPMO website: http://www.bolpatra.gov.np/egp, before the above deadline and as specified in the Instructions to Bidders.
- 6. Bids must be valid for 120 days after the date of bid opening and must be accompanied by Bid Security not less than the amounts mentioned on the table below or the equivalent in a freely convertible foreign currency. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal. The Bid Security must be valid for thirty (30) days beyond the bid validity period. Bids will be opened in the presence of the bidders' representatives, who choose to attend in person, at the address above at 14:00 hours (Nepal Time) on 4 November 2019.
