1. The Aathbiskot Municipality *has allocated funds or received a grant* from *Government of Nepal* towards the cost of Construction of different infrastructure of Aathbiskot Municipality and intends to apply part of the funds to cover eligible payments under the Contract *for given below*. Bidding is open to all eligible as per Section V of bidding document.
2. ***Aathbiskot Municipality*** invites sealed bids or electronic bids from eligible bidders for the construction of following infrastructure of ***Aathbiskot Municipality*** under National Competitive Bidding as the following Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs.4,00,00,000.00 without VAT (**Only for serial no. 1 & 6 given below**)
  - Minimum Work experience of similar size and nature: NRs.2,70,00,000.00 without VAT (**Only for serial no. 1 & 6 given below**)
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of the Bidding Document. (**Only for serial no. 1 & 6 given below**)
  4.
