A Complete set of Bidding document in English may be purchased from the address below by interested bidders within 15 days (Upto 2075/09/25) from the date of publication at office hours on the submission of a written application along with the copy of company registration certificate, Tax clearance up to FY 074/075 and upon payment of a non-refundable fee of **Rs. 3,000.00 (in words, three thousand rupees only)** deposited at:

3. Sealed Bids must be submitted to Aathbiskot Municipality Office on or before 12.00 hours on 16th day (2075/09/ 26) from the date of publication. Documents received after this deadline shall not be accepted. For submission of hard copy, the bid documents purchased from Aathbiskot Municipality is only acceptable.
4. In the case of discrepancies or error in bid documents, bid notice or any other documents, Aathbiskot Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear if any discrepancy may occur then the figure written in word is valid.
5. Bids shall be opened in the presence of Bidders' representatives, who choose to attend with original related documents at 2:00 PM on 15th day (2075/09/26) of Notice Published in Aathbiskot Municipality, Rukum (West). Bids must be valid for a period of **90 days** counting from the day of bid opening.
6. Bid shall be accompanied by a bid security of an amount as shown in the above table. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the above address or a bid bond issued by a bank approved by Nepal Rastra Bank valid beyond a month from bid validity period and submit the original receipt of the deposited amount of cash along with the bid.
7. After acceptance of bid, the Performance bond 5% of the quoted bid amount should be authorized from recognized commercial bank of Nepal, which shall be valid one month more beyond the Warranty period of the vehicle.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. Aathbiskot Municipality office will not be responsible for any costs or expense incurred by bidders for preparation or delivery of Bids. Except the mentioned clauses all other conditions of the bidding process must be followed the public Procurement act 2063, Aathbiskot Public procurement regulation 2075.
- 10. If bidders are not manufacturer, they must submit sole authorization letter from the manufacturer or from the authorized distributor of the manufacturer.**
11. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Noncompliance with this instruction shall result in disqualification.
12. Aathbiskot Municipality office reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
